1. Main purpose and number of students to be granted

1.1 Main purpose

We at Kanagawa University of Human Services encourage international students, with at least a bachelor degree (or an equivalent degree) with excellent grades from overseas universities and other higher education institutions, to apply to the Graduate School of Health Innovation (hereinafter SHI) by offering the scholarship exclusively for international students.

SHI aims to develop human resources who can innovate social systems and technologies in the fields related to healthcare, medical care, and social welfare.

The purpose of our scholarship is to provide financial support for new foreign students who are going to come to Japan solely for enrolling in an SHI program, and hence to help advance research activities during the enrollment period in Japan.

The decisions for this international student scholarship are made separately from those for an SHI graduate program. If the applicant is not accepted by an SHI program, this international student scholarship will cover the entrance examination fee only.

1.2 Number of students to be granted

2. Application requirements

SHI accepts applications from international students who do not have Japanese nationality at the time of application, who will apply for admission to the SHI Master's course, and who satisfy the following qualifications.

Please note that the recipients of this scholarship are not allowed to receive any other scholarships.

- (1) Those who have foreign nationality and who do not have permanent resident status in Japan.
- (2) Those who were awarded a bachelor's degree or equivalent in a foreign country (or who are expected to be awarded a bachelor's degree or equivalent in a foreign country) by the end of March 2024.

3. Scholarship benefits

(1) Entrance examination fee

Entrance examination fee which must be paid when applying for the 2024 entrance examination of SHI.

(2) Allowance

Monthly stipend of JPY 130,000 from April 2024 to March 2026 after arriving in Japan for commodities purchase, room rent, and utilities payment.

*In the case where you do not stay for a full month, the amount of allowance of the month may be adjusted for the number of days of your stay in Japan.

*If it is not confirmed that the recipient has been living in Japan, the allowance may not be granted.

(3) Lump Sum

JPY200,000 as the expenses for furniture, home appliances and so on after arriving in Japan.

(4) Entrance Fee / Course Fee

Entrance fee which must be paid during the admission procedure period, and course fee which must be paid during the first and second semesters.

*Entrance examination fee, entrance fee, and course fee will be deducted from your scholarship internally by SHI, without being transferred to your bank account.

4. Application procedure

4.1 Documents required for application

Download the documents required for application from the SHI website (https://www.kuhs.ac.jp/shi/en/admissions/), and submit them by referring to "4.2. Method of application."

The certificate must be issued by the relevant institution with an official

5. Precautions when submitting applications

 Application cannot be accepted unless all the application documents are in place. Please make absolutely sure that everything is in order when submitting your application.

Please note that we will not accept any documents other than we have mentioned at 4.1.

- (3) Changes and modifications in the content of the application documents cannot be approved after they have been submitted. If, however, changes and modifications have been made in your name, address, and/or phone number, please contact the SHI Administrative Office.
- (4) Even if you were selected, it may be canceled if the factually inaccurate descriptions are found in the submitted application documents.
